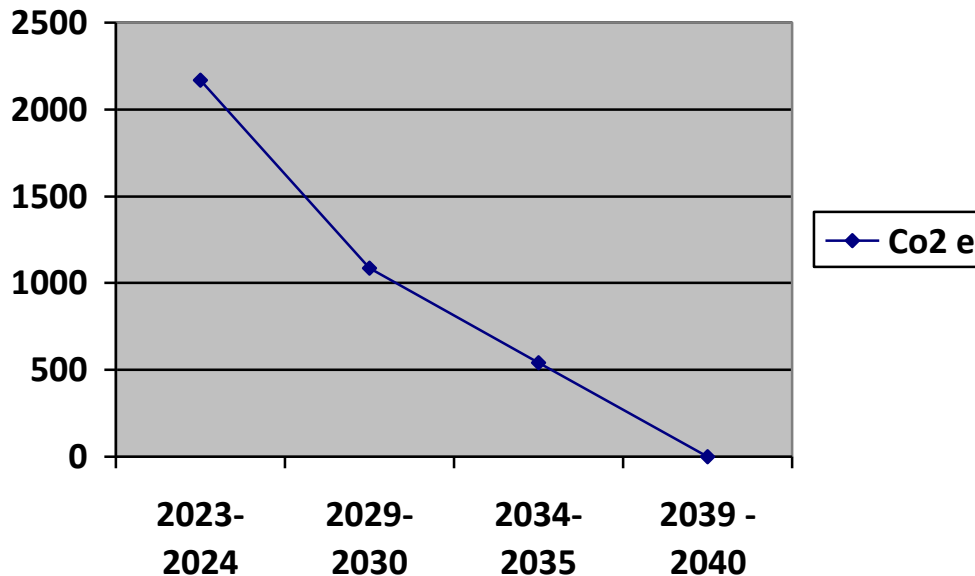

In order to start and continue our progress to achieving Net Zero we have adopted the following carbon reduction targets:

We project that carbon emissions will decrease over the next six years to 1085 tonnes Co2 e by 2030 and to 543 tonnes Co2 e by 2035 achieving Net Zero by 2040.

Completed Carbon Reduction initiatives

The following environmental management measures and projects have been completed or implemented since the 2023-2024 baseline.

- A move in summer 2024 to premises with solar panels
- A move to a utility provider which provide 100% renewable energy in August 2024
- Installation of our first fully electric van in January 2024
- Adaption of LED lighting in our offices achieved in June 2024
- Monitoring and communication with supply chain.
- Signed up to 'SME Climate Hub' in August 2024

In the future we hope to implement further measures such as:

- Continue to move to fully electrically powered Vans by 2030
- Communicating with our Suppliers & Clients upstreams and downstreams on their targets to reach Net Zero to lead inspire & learn to reach our joint goals.
- To actively participate in SME Climate Hub with required reports to follow our target.
