



Commitment Guide

This guide provides information about the [SME Climate Commitment](#) and the commitment process on the [SME Climate Hub](#).

What is the SME Climate Commitment?

The [SME Climate Commitment](#) is a public net zero commitment aligned with the latest climate science and the criteria of the [UN High Level Champions Race to Zero campaign](#).

The [SME Climate Commitment](#) is a great starting place for SMEs to immediately commit, begin taking action on their scopes 1, 2, and 3 emissions, and publicly report on that action to their customers or other stakeholders.

The Commitment process is free and includes a simple sign-up and due diligence process.

SMEs that make the [SME Climate Commitment](#) will join the SME Climate Hub community and become members of the [UN High Level Champions Race to Zero campaign](#).

THE SME CLIMATE COMMITMENT

Recognizing that climate change poses a threat to the economy, nature and society-at-large, our company commits to take action immediately in order to:

- Halve our greenhouse gas emissions before 2030
- Achieve net zero emissions before 2050
- Disclose our progress on a yearly basis

In doing so, we are proud to be recognized by the UN High Level Champions Race to Zero campaign, and to join governments, businesses, cities, regions, and universities around the world with the same mission.

Who should make the SME Climate Commitment?

The [SME Climate Commitment](#) is designed specifically for small and medium-sized enterprises to align their goals and action with the latest climate science. We define an SME as a company or an organization with up to 500 employees. SME subsidiaries, even if their parent companies exceed 500 employees, are welcome to submit individual targets through the [SME Climate Hub](#).

The [SME Climate Commitment](#) should be signed by the CEO or any other person who has the authority to represent the company. After completing the commitment process, the company will be expected to do its utmost to deliver on the [SME Climate Commitment](#).

What is the process for making the SME Climate Commitment?

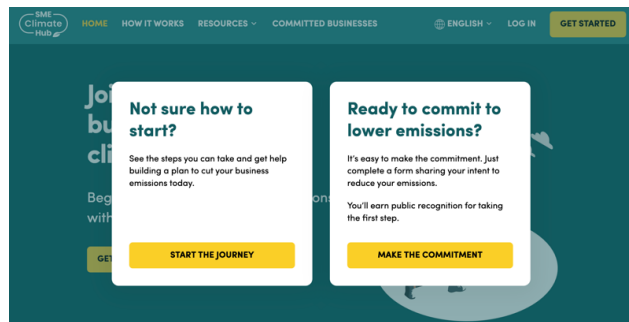
The SME Climate Hub has developed a simplified commitment sign-up process specifically for SMEs:



1. SME completes commitment form

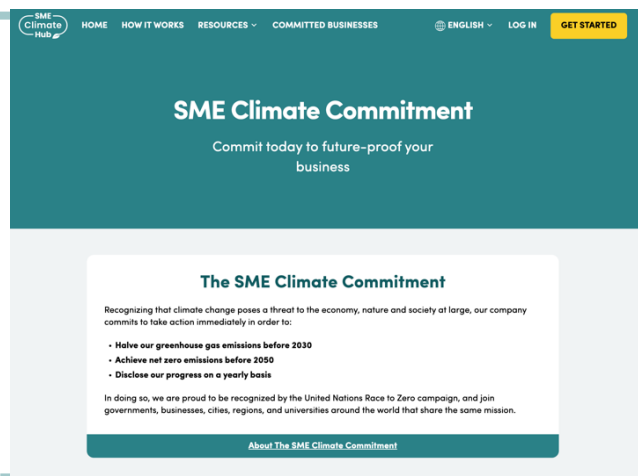
SME navigates to the [SME Climate Hub website](#)

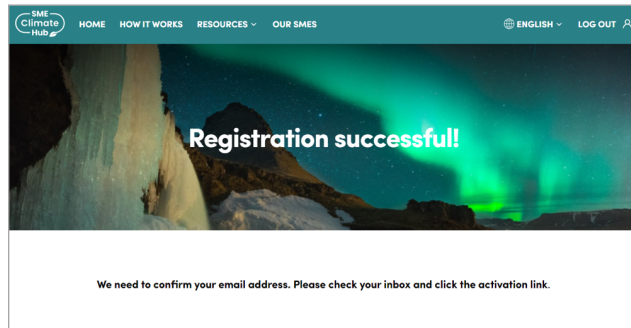

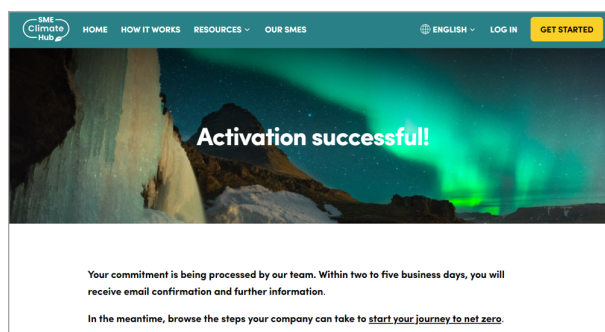

SME receives a notification confirming that their commitment is being processed

3. The SME Climate Hub reviews the SME information

The SME Climate Hub manually reviews each SME's information to ensure they fulfill the criteria of the SME Climate Hub and Race to Zero

There is a 2-5-business day waiting period between making the commitment and approval

4. The SME Climate Hub confirms approval

An email is sent to the SME confirming that the commitment is approved

SME should set their password using the link in the email

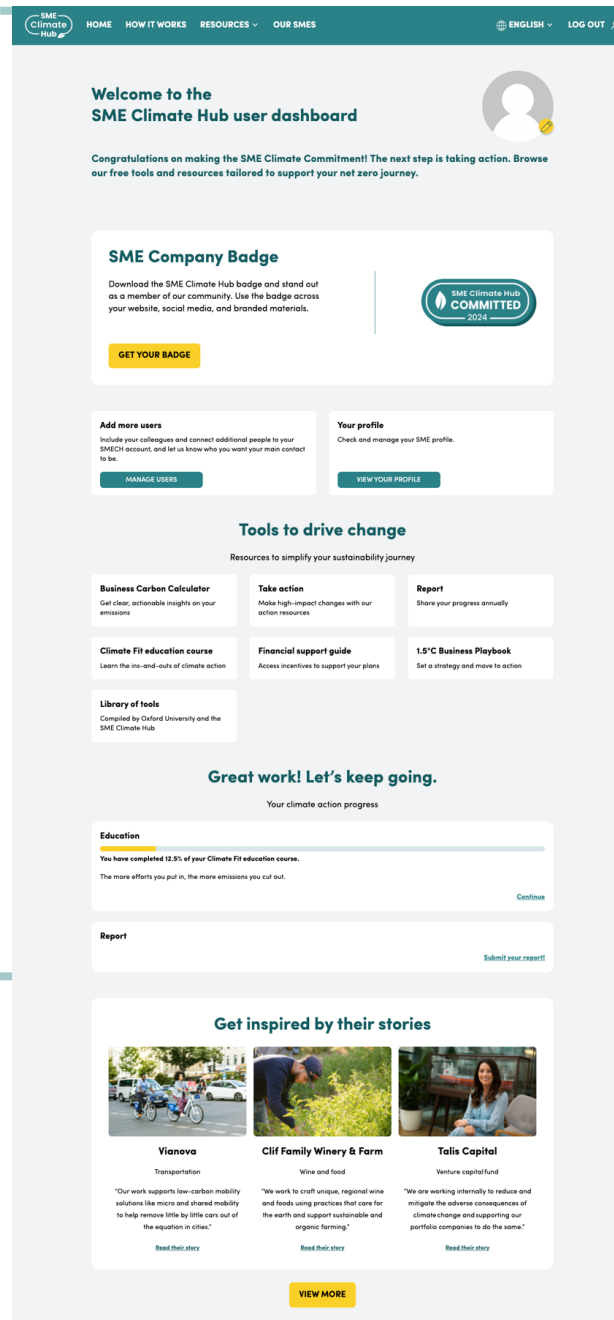
The resources will help you to calculate your emissions, learn how to take action and access support to reduce your emissions and report on yearly progress.
