## Emissions reduction targets

In order to continue our progress to achieving Net Zero, we have adopted the following carbon reduction targets.

Scope 2:

- Ensure that office lights and power is switched off, aiming to reduce the electricity emissions from 1.46 to 1.1 by 2028
- Ensure that heating is only used when absolutely necessary, encourage staff to wear jumpers and layers, reducing the heating from 1.21 to 0.8 by 2028
- Reduction in business travel. Aiming to reach 0.14 by 2028
- Reduction in the use of Office supplies. Aiming to be completely paperless by 2028 reducing our emissions to 0

We project that carbon emissions will decrease over the next five years to **2.04 tCO<sub>2</sub>e by 2028**. This is a reduction of **23.6%**

## Carbon Reduction Projects

### Completed Carbon Reduction Initiatives



The following environmental management measures and projects have been completed or implemented since the 2023 baseline.

- Paperless policy, staff are encouraged to use as little paper as possible and all paperwork's and documentations are transitioning to online service.
- Public transport scheme, all staff are encouraged and supported to use public transport where reasonably able to.
- 'switch it off' scheme where staff are encouraged and reminded to help in little ways, such as turning off the office lights when natural light is available, ensuring all lights and outlets are switched off at the end of the day. When being away from the desk for quite some time, switch of the computer instead of leaving it on standby.

In the future we hope to implement further measures such as:

- We are also aiming to reduce our use in heating within the office, encouraging staff to wear layers.
