The GHG Protocol Defines Emissions In Three Scopes:



SCOPE 1

Direct emissions come from sources owned and controlled by the company such as vehicles or company facilities



SCOPE 2

Indirect emissions from energy (such as electricity or heating and cooling) consumed at company facilities.



SCOPE 3

Indirect emissions that occur upstream and downstream in the company's Value chain as a consequence of the company's operations. These emissions are based on activities such as Travel, Office Supplies, Software, Services

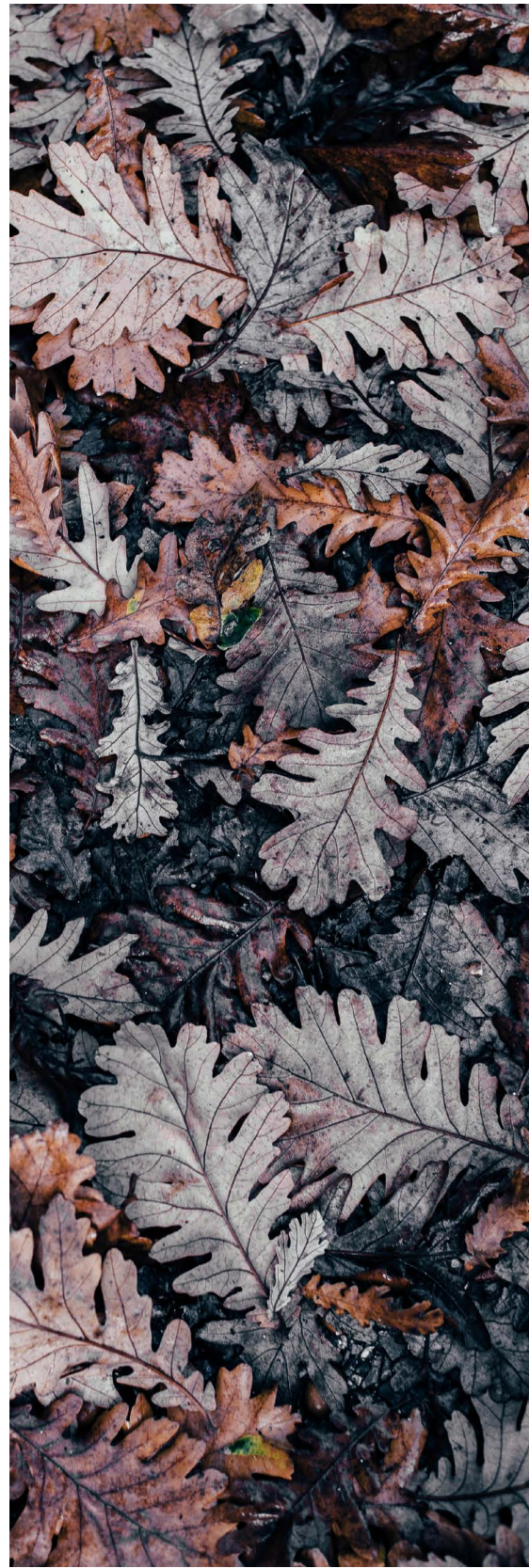

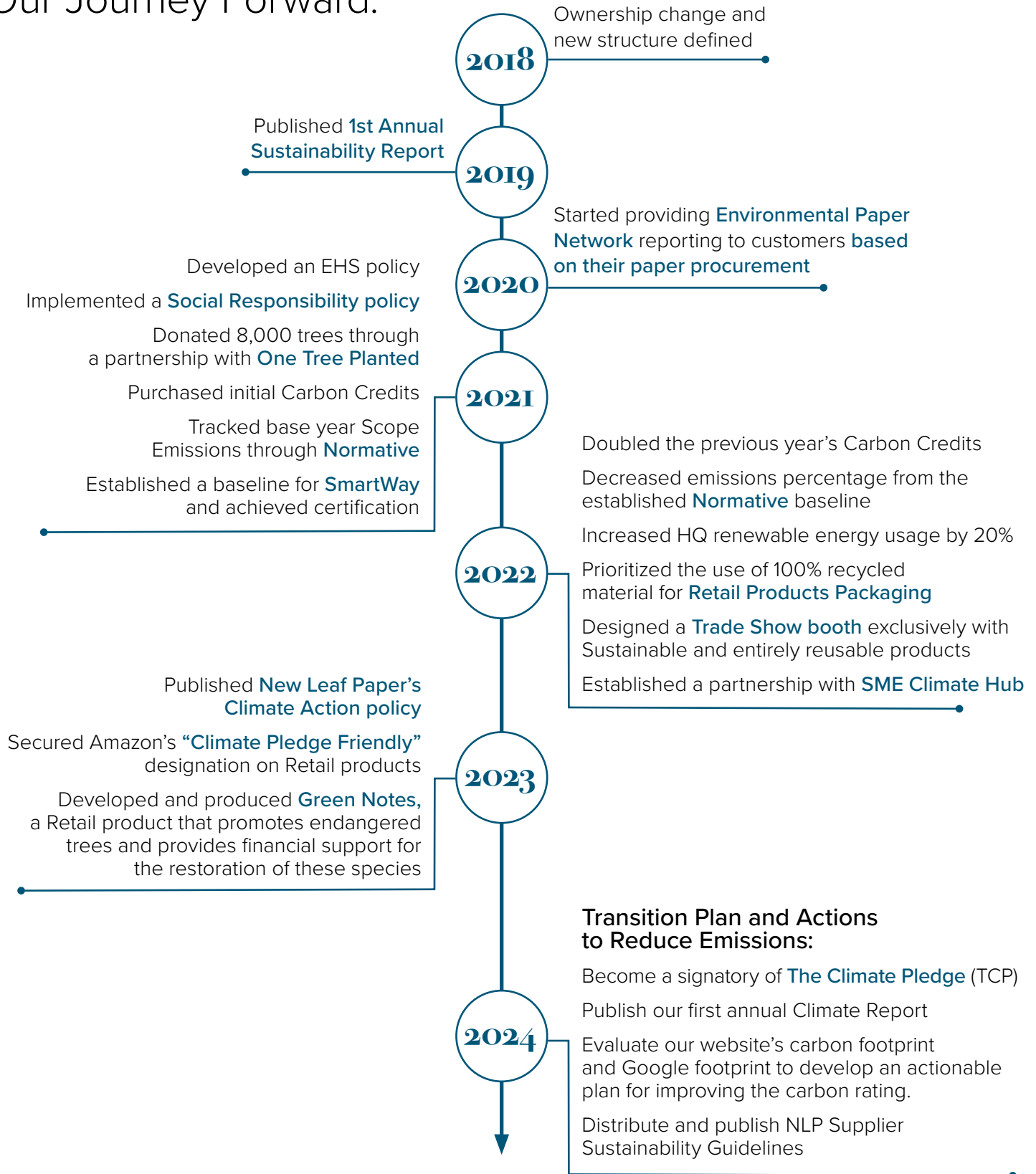



